Payroll Deduction

Deductions will begin the first pay period of the month following the date next to your signature and will continue until you request a change in writing.

Donations via Cash, Check or Credit Card

One Time Donations via cash or check will be processed accordingly. Credit Card Donations will be charged once at time of form delivery.

- Quarterly Donations via cash or check will be invoiced via email.
- Quarterly Credit Card Donations will be charged the last month of each quarter: 3/15, 6/15, 9/15, and 12/15.

Paid Time-Off (PTO) Donation

By requesting to make the following PTO donation election to Eskaton Foundation.

I understand that:

- PTO donations are subject to all applicable payroll taxes and will be reported as wages on my IRS W-2 form in the calendar year in which the PTO hours are donated.
- PTO donations are deducted only from the last paycheck of each quarter of the calendar year (March, June, September, December).
- Any ongoing PTO donation election will be in effect until discontinuance is requested by me in writing.
